PRODUCT DESCRIPTION: A water based, synergized dip concentrate insecticide with up to 30 days residual effects. Kills fleas, mange mites & ticks, including deer ticks. For use on dogs & their premises.

SECTION III (Physical Data)

SECTION IV (Fire & Explosion Data)

Flammable, Non-Explosive. Do not store near heat or open flame.
Extinguishing Media: Chemical or foam.

SECTION V (First Aid Measures)

IF SWALLOWED: Call a physician or Poison Control Center immediately.
Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor.
Do not give anything by mouth to an unconscious or convulsing person.

IF IN EYES: Hold eyes open & rinse slowly & gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

SECTION VI (Spills or Leak Procedures)

Absorb in saw dust or sand & dispose of properly.

SECTION VII (Handling, Storage & Disposal)

HANDLING: Wear rubber gloves, goggles & boots. Wash hands after using.

STORAGE: Store in a cool, dry area inaccessible to children and pets.

DISPOSAL: Securely wrap original container in several layers of newspaper & discard in trash. Do not reuse container.

SECTION VIII (Environmental Hazards)

This product is toxic to fish, birds & other wildlife. Do not apply directly to any body of water. Do not contaminate water when disposing of dip or equipment washwaters.

SECTION IX (Precautionary Statements-Hazards to Humans & Domestic Animals)

Hazards to Humans: Causes moderate eye irritation. Harmful if swallowed or absorbed through the skin. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap & water after handling. Remove contaminated clothing and wash clothing before reuse. Groomers or other persons applying the product frequently must wear chemically resistant gloves.

Hazards to Domestic Animals: For external use on Dogs only. **DO NOT USE ON CATS.** Do not use on puppies under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals.

Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, remove collar & bathe your pet with mild soap & rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Certain medications can interact with pesticides. Consult a veterinarian before using on medicated dogs.
